
Introduction

The demo board included in this shipment converts 3V to 5.5V input to 12V output for up to 500mA load current using the LM2735X 1.6MHz DC-DC switching converter in the 8-Pin eMSOP package. This is a 2-layer board using the bottom layer as a ground plane.

A bill of materials below describes the parts used on this demo board. A schematic and layout have also been included below along with measured performance characteristics. The above restrictions for the input voltage are valid only for the demo board as shipped with the demo board schematic below.






LM2735X 8-Pin eMSOP Schematic




Pin Description for 8-Pin eMSOP


Pin	Name	Function		
1	NC	No Connect		
2	PGND	Power ground pin. Place PGND and output capacitor GND close together.		
3	VIN	Supply voltage for power stage, and Input supply voltage.		
4	EN	Shutdown control input. Logic high enables operation. Do not allow this pin to float or be greater than VIN + 0.3V.		
5	FB	Feedback pin. Connect FB to external resistor divider to set output voltage.		
6	AGND	Signal ground pin. Place the bottom resistor of the feedback network as close as possible to pin 5		
7	SW	Output switch. Connect to the inductor, output diode.		
8	NC	No Connect		
DAP	GND	ignal & Power ground. Connect to pin 2 & pin 6 on top layer. Place 4-6 via's from DAP to bottom yer GND plane.
